Estimated 2021 Short Term and Long Term Capital Gains - *Actual distribution may be higher or lower*

The following capital gains table has been prepared for the Boston Trust Walden Funds to assist shareholders with tax planning for 2021. The actual Short Term/Long Term Capital Gains distribution in December of 2021 (Record 12/13, Ex 12/14 and Pay 12/15) is based on the higher of the 12/31/20 Fiscal Year End and 10/31/21 Excise Tax Measurement Period figures. The data below reflects each Fund's accumulated gains through 10/31/21. Please note that shares outstanding on record date will be higher or lower than the shares outstanding on the date on which the estimates are based, which could increase or decrease the per share estimates. Accordingly, actual distributions may differ considerably.
